India has its own A.Y.U.S.H. Ministry promoting Ayurveda, Yoga, Unani, Sidda and Homeopathy medicinal practise and set up All India Institute of Ayurveda in Delhi and runs Homeopathy colleges and supports Naturopathy Centres.

It is felt that there should be one Centre which can cater all types of medicinal practices under one roof. This will her desire to and also help in getting the support of other Asian Countries such as China, Thailand, Korea, Japan, etc to bring in their medicinal practices at Uttarakhand, it is proposed to set up a Multipathy Integrated Holistic Medical Centre with the follows Aims & Objectives:
